

The intention behind weekend field trips and programs like ELOP (Expanded Learning Opportunities Program) is to provide students with hands-on, real-world learning that enhances the classroom experience. However, we recognize that the cost of some of these opportunities can raise concerns, and we continue to actively explore more cost-effective options and partnerships that can provide meaningful experiences without placing unnecessary financial strain on the District.</p> <p>The district has presented a fiscal stabilization plan to the board of education that includes a review of all programs and related expenditures. We want to provide programming that is equitable and accessible to all students while also engaging them academically. Ultimately, our next steps are to refine what we do in ways that are fair, transparent, and aligned with the program's purpose and funding guidelines.</p> <p>Regarding the ELOP spring session, we understand that families may need downtime during school breaks. While we aim to offer options that meet diverse needs—including childcare, academic support, and enrichment—participation is always voluntary.</p> <p>As for school supplies, we continue to assess the sustainability and impact of District-provided supplies. Our goal has always been to remove barriers to learning, especially for families experiencing financial hardship.</p>
