Section 34. Hazardous Materials of the Instructions to Bidders, is replaced by the following: 34. HAZARDOUS MATERIALS

Portions of the Janson Southwest parking lot paint striping preliminarily tested positive for leadbased paint. Follow-up confirmation testing was performed. Based on the confirmation sampling and sample analysis by an accredited laboratory, the findings for the white painted stripes (also referred as decals in the field paperwork) are below the analytical "Reporting Limit." The Report by CES Environmental with the confirmation testing is dated March 14, 2024 (Revision 1) and is issued concurrently with this Addendum as document E.1.A. (The original Report dated March 7, 2024 is also issued concurrently with this Addendum for reference as document E.1.B., although please note that there is an error in the original report that incorrectly referred to the striping as red and not white.) Alterations required by this project do not appear to involve hazardous materials based on review of testing reports, however the Bidder shall review all testing reports for itself and confirm that areas of work do not contain hazardous materials. Various portions of the site have been tested at different times, so results are contained in various reports.
