- *(ii) Each teleconference location be accessible to the public;*
- (iii) *Members of the public may address the body at each teleconference conference location;*
- (iv) State and local bodies post agendas at all teleconference locations;
- (v) At least one member of the state body be physically present at the location specified in the notice of the meeting; and
- (vi) During teleconference meetings, at least a quorum of the members of the local body participate from locations within the boundaries of the territory over which the local body exercises jurisdiction
